**BUYERS OBLIGATIONS:**

1. The foster family acknowledges that this dog will be returned to the breeder owner for up to four, no less than two, litters within the next 7 years from the date of this contract. The dog will be mated when the breeder owner chooses and will reside with the breeder owner from the time of mating until the litter has been weaned.
2. The foster family agrees that this dog will be maintained in a manner consistent with its good health, safety, and well-being. Immunization or titers will be kept up to date, as per seller's instructions. This dog will not be permitted to run loose without being under the control and supervision of the foster family at all times. If boarding services are required this dog is to be with the owner breeder.
3. If it should become necessary for any reason for the foster family to dispose of this dog, said dog must be returned to the breeder owner.
4. The foster family will be responsible for having this dog spay, when the breeder owner gives the foster family a written request stating her intentions to no longer breed the said dog.
5. The foster family is responsible for all veterinary bills, with the exception of veterinary bills associated with breeder specific clearances (i.e. blood work, hips and eye clearances).
